- All new construction and multifamily projects require pre-approval.
- Instant Discounts over \$7,500 require pre-approval and a post-inspection.
- Instant Discount amount cannot exceed 100% of the sales price.
- You must be an active Eversource or United Illuminating commercial customer to receive an Instant Discount which will be applied at the point-of-sale on your invoice.
